McCann Took \$16,000 From Sweetwater Contractor Convicted In Corruption

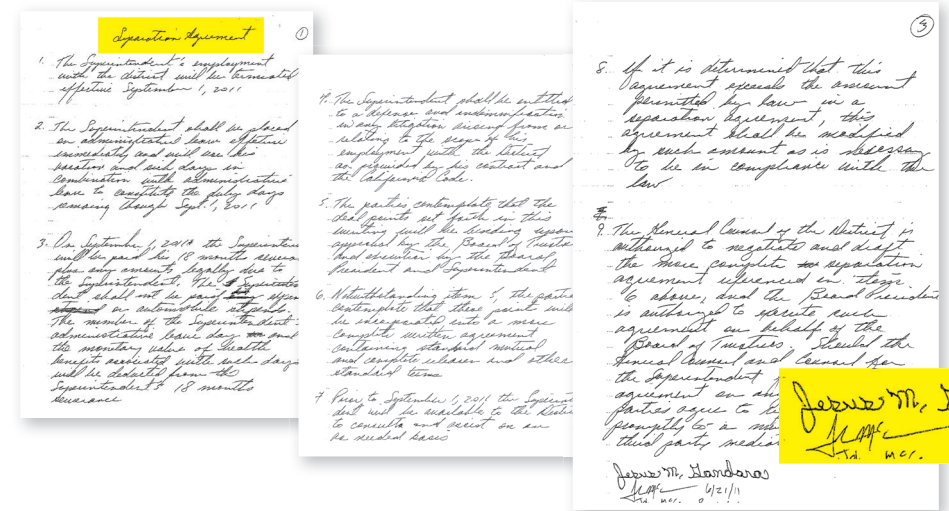
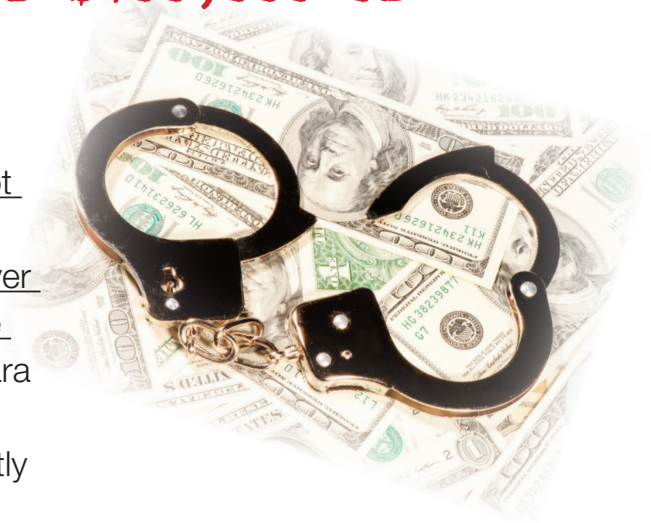

McCann Voted To Give Corrupt Superintendent Over \$400,000 Of Our Kids' Money
