



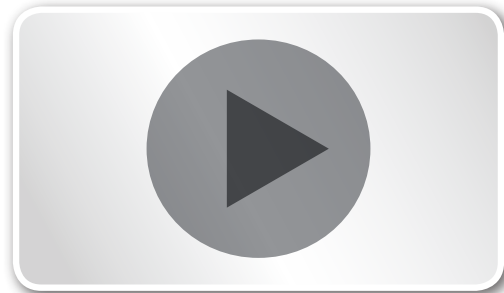
# WE WANT YOU!
